**POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD  
ON 7 AUGUST 2020**

Reference is made to the notice of annual general meeting (the “**AGM**”) dated 29 June 2020 (the “**AGM Notice**”) of Guru Online (Holdings) Limited (the “**Company**”) and the circular of the Company dated 29 June 2020 (the “**Circular**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Circular.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that all the proposed resolutions (the “**Resolutions**”) as set out in the AGM Notice were duly passed by the Shareholders by way of poll as ordinary resolutions at the AGM held at 3:30 p.m. on Friday, 7 August 2020 at 4/F., KOHO, 73-75 Hung To Road, Kwun Tong, Hong Kong.

The scrutineer of the AGM was Tricor Investor Services Limited, the Hong Kong branch share registrar and transfer office of the Company.

As at the date of the AGM, the total number of issued Shares was 1,667,200,000 Shares, which represented the total number of Shares entitling the Shareholders to attend and vote for or against the Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in rule 17.47A of the GEM Listing Rules. No Shareholder was required under the GEM Listing Rules to abstain from voting on any of the Resolutions at the AGM. None of the Shareholders has stated his/her/its intention in the Circular to vote against or to abstain from voting on any of the Resolutions at the AGM. The Shareholders and authorised proxies holding an aggregate of 525,053,000 Shares carrying voting rights had voted at the AGM.
